\*On January 4, 2018, Council approved the following process for nominating and appointing to fill the At-Large (B) vacancy:

- January 9, 2018: Each councilmember will submit up to three choices from the list of applicants to the Clerk of the Council. The Clerk will read the submitted names into the record and the top five vote-getters will advance to the initial final pool of applicants. Once the initial final pool is established, any councilmember may nominate any other applicant to the final pool.
- January 16, 2018: The final pool of applicants will be allowed to give a three-minute oral presentation to the council.
- January 16, 2018: It is anticipated that council will appoint to fill the At-Large (B) vacancy.
