7 AN ORDINANCE REGARDING THE MATTER OF
8 ESTABLISHING PARKING CONTROL ON
9 LAKEWAY DRIVE

11 WHEREAS, the Whatcom County Council is authorized under RCW 46.61.570 to
12 restrict parking on certain County roads; and
13

14 WHEREAS, a study was conducted by the Whatcom County Engineer's office in
15 cooperation with the Whatcom County Sheriff's office; and

17 NOW, THEREFORE, BE IT ORDAINED that a No Parking Anytime zone be
18 established on Lakeway Drive on the north side of the road from 100 feet west to
19 200 feet east of Oriental Avenue and on the south side of the road from 100 feet
20 west to 100 feet east of Oriental Avenue, Section 27 and 34, Township 38 North,
21 Range 3 East, W.M.

23 BE IT FURTHER ORDAINED that the County Engineer is hereby directed to
24 post the appropriate signs and that the Whatcom County Sheriff and the
25 Washington State Patrol be notified by a copy of this ordinance.
