ORDINANCE NO. 92-036

REVISION TO ORDINANCE 91-055
CHANGING THE NAME AND EXPANDING
THE USE OF THE REVOLVING FUND

WHEREAS, both of the Divisions of Mental health and Alcohol and Substance Abuse of the Department of Social and Health Services have contracted funds to Whatcom County to provide for services to consumers and to community groups working with prevention; and

WHEREAS, these funds allow for the payment of the cost of specific and unusual therapy, for essential daily living, recreation, supervision, conference attendance, conference preparation and set-up, and a number of other items either to treat or prevent problems of either Mental Illness or Substance Abuse in the Community;

NOW THEREFORE BE IT ORDAINED, the existing Resource Management Revolving Fund is hereby renamed the Mental Health/Substance Abuse Revolving Fund, and the total amount of the fund is increased from \$3,960.00 to \$5,000.00.

BE IT FURTHER ORDAINED, this revolving account shall be terminated on August 1, 1993 unless extended by further action of the Council.
