ORDINANCE NO. 92-066
AMENDMENT TO 1992 BUDGET

WHEREAS, the 1992 budget was approved November, 1991.

WHEREAS, changing circumstances require modifications to the approved 1992 budget.

WHEREAS, by motion on August 11 the County Council stated they wished to take advantage of the opportunity to apply for an ISTEAs grant for non-motorized transportation.

WHEREAS, funds are available in the Paths and Trails Fund for this purpose.

NOW, THEREFORE, BE IT ORDAINED by the Whatcom County Council that the 1992 Whatcom County budget ordinance 91-83 is hereby amended by adding the following amounts to the Park Fund Budget:

Park Fund (10600 573.10 41) 4,500

This appropriation shall be financed by an operating transfer from the Paths and Trails fund (13100.397).
