5 ORDINANCE AMENDING ORDINANCE NO. 89-56  
6 ASSIGNING THE NON-EXCLUSIVE FRANCHISE FROM  
7 GLACIER CABLE PARTNERS LIMITED TO  
8 TCI CABLEVISION OF WASHINGTON, INC.

9 WHEREAS, on July 6, 1989, Whatcom County Council approved and granted a  
10 franchise to Glacier Cable Partners Limited for a period of twenty-five (25)  
11 years; and

12 WHEREAS, Phoenix Glacier Cable Joint Venture currently owns and operates  
13 the cable television system under the franchise as a result of the insolvency of  
14 Glacier Cable Partners Limited; and

15 WHEREAS, Phoenix Glacier Cable Joint Venture desires to assign the  
16 franchise to TCI Cablevision of Washington, Inc. upon consummation of the sale  
17 of the system; and

18 WHEREAS, Phoenix Glacier Cable Joint Venture will transfer all rights,  
19 obligations, title, and interest over to TCI Cablevision of Washington, Inc.;

20 NOW, THEREFORE, BE IT ORDAINED that, pursuant to Section 17 of Ordinance  
21 No. 89-56, the Whatcom County Council hereby consents to the transfer and assign-  
22 ment of the franchise to TCI Cablevision of Washington, Inc., which shall receive  
23 all benefits and be held to all of the responsibilities of the franchise arising  
24 after consummation of the sale described above.

25 BE IT FURTHER ORDAINED that this consent shall be considered effective  
26 as of the date of consummation of the sale to TCI Cablevision of Washington,  
27 Inc. as described above.
