11 Block 3, Town of Deming to close the alley lying adjacent to the south line of said Lot

15 said alley as a through alley, and

17 WHEREAS, trash is being discarded in said alley, and

19 WHEREAS, through pedestrian traffic interferes with residential usage on said Lot 9,

22 WHEREAS, the County Council had a Hearing on the proposed closure at its June 22,
23 1993 meeting and is authorized to close the alley according to the provisions of RCW
24 36.32.120.


26 NOW, THEREFORE, BE IT RESOLVED by the Whatcom County Council:


28 that the Administration is directed to allow the alley south of Lot 9, Block 3, Town of


