ORDINANCE NO. 93-049

REPEALING SECTION 2.34 OF THE WHATCOM COUNTY CODE,
REGARDING THE COMMUNITY RECREATION COMMISSION

WHEREAS, in the course of updating references to "county commissioners" in the Whatcom County Code, amendments were proposed to Section 2.34, relating to a Community Recreation Commission; and

WHEREAS, the County Executive has noted that since 1978 there appears to have been no activity of a Community Recreation Commission, and it may in fact not exist; and

WHEREAS, under the circumstances section 2.34 of the Code should be repealed; and

WHEREAS, repealing the section at this time will help the soon-to-be published County Code to be as up-to-date and accurate as possible;

NOW, THEREFORE, BE IT ORDAINED by the Whatcom County Council that Whatcom County Code Section 2.34, Community Recreation Commission, is hereby repealed.
