ORDINANCE NO. 93-050

REPEALING SECTION 2.52 OF THE WHATCOM COUNTY CODE,
REGARDING THE MULTIPURPOSE COMMUNITY CENTER

WHEREAS, in the course of updating references to "county commissioners" in the Whatcom County Code, amendments were proposed to Section 2.52, relating to a Multipurpose Community Center; and

WHEREAS, the County Executive has noted that several years ago Bellingham changed its code to make the Bellingham-Whatcom County Museum a city department run exclusively by Bellingham, so the joint board of the Multipurpose Community Center is no longer functioning; and

WHEREAS, under the circumstances section 2.52 of the Code should be repealed; and

WHEREAS, repealing the section at this time will help the soon-to-be published County Code to be as up-to-date and accurate as possible;

NOW, THEREFORE, BE IT ORDAINED by the Whatcom County Council that Whatcom County Code Section 2.52, Multipurpose Community Center, is hereby repealed.
