7 AN ORDINANCE REGARDING THE MATTER OF  
8 ESTABLISHING PARKING CONTROL ON SOUTH BEACH WAY

10 WHEREAS, the Whatcom County Council is authorized under RCW 46.61.570  
11 to restrict parking on certain County roads; and

12  
13 WHEREAS, referenced in Resolution 84-55, that the road right-of way shall  
14 not be blocked in any way; and

16 WHEREAS, a review was conducted by the Whatcom County Engineer's office  
17 and determined that a "No Parking, Loading Zone" should be established on South  
18 Beach Way.

20 NOW, THEREFORE, BE IT ORDAINED that a No Parking Loading Zone  
21 be established on South Beach Way west of Sucia Drive, Section 5, Township 38  
22 North, Range 1 East, W.M.

23  
24 BE IT FURTHER ORDAINED that the County Engineer is hereby directed  
25 to post the appropriate signs and that the Whatcom County Sheriff and the  
26 Washington State Patrol be notified by a copy of this ordinance.

28 Provisions of this ordinance are hereby added to Whatcom County Code  
29 Section 10.24
