ORDINANCE NO. 94-020

AN ORDINANCE REGARDING ESTABLISHING SPEED LIMITS
ON CERTAIN COUNTY ROADS

WHEREAS, the Whatcom County Council is authorized under RCW 46.61.415 to establish speed limits on certain County roads; and

WHEREAS, an engineering study was conducted by the County Engineer's office;

NOW, THEREFORE, BE IT ORDAINED by the Whatcom County Council that the speed limits be established as follows:

- 1) 25 mph on all roads within the plat of Bellaire Estates; Section 27, Township 39 North, Range 2 East, W.M.
- 2) 25 mph on all roads within the plat of Birch Bay View; Section 23, Township 40 North, Range 1 West, W.M.

BE IT FURTHER ORDAINED that the County Engineer is hereby directed to install the appropriate signs and that the Whatcom County Sheriff and the Washington State Patrol be notified by a copy of this ordinance.

Provisions of this ordinance are hereby added to Whatcom County Code, Section 10.04.030.






