ORDINANCE NO. 95-066

ESTABLISHING NO SHOOTING ZONE COVERING THE NELSON ROAD AREA

WHEREAS, a citizen has petitioned the Whatcom County Council for the formation of a no-shooting zone in the established residential area known as the Nelson Road Area; and

WHEREAS, the petitioner has submitted the following to the council: Signatures of at least sixty percent of persons owning property within the proposed boundaries of the zone; legal description of the proposed boundaries of the no-shooting zone; a map showing the proposed boundaries; cover letter explaining the reasons petition would like the no-shooting zone to be formed, a history of shooting violations in the area, the name, address, and phone numbers of a person who will act as liaison with the county council concerning the proposed zone; and

WHEREAS, Whatcom County Council has in the past designated areas as no-shooting zones in the interest of public health, safety and welfare;

NOW, THEREFORE, BE IT ORDAINED by the Whatcom County Council that a new section of the Whatcom County Code 9.32 be added to create a new no-shooting zone, described as follows:


A. No shooting zone [*number to be assigned by Code revisor*] also is known as the Nelson Road Area.


B. The boundaries are described as follows: portions of the east one-half of Section 17, Township 38 North, Range 5 East of W.M., said portions further described as

1 follows: The south one-half of the northeast one-quarter and All of the southeast one-
2 quarter lying west of Nelson Road, except the southerly 300 feet thereof and All of the
3 northeast one-quarter of the southeast one-quarter lying east of Nelson road, except the
4 southerly 510 feet thereof. All in Whatcom County, Washington.


