HEARING AND NOTICE OF HEARING ON
SALE OF COUNTY TAX TITLE PROPERTY
REQUEST NO. 95-2

WHEREAS, the following described property is now, and has been the property of the County of Whatcom, State of Washington since December 1991; and

WHEREAS, the Whatcom County Council does deem it in the best interest of the County and the people thereof that said property be sold; and,

WHEREAS, the Whatcom County Property Management Committee has recommended the sale of the subject property to the City of Everson, Washington, at no less than the sum of taxes owing plus any additional costs and liens at the time of foreclosure; and,

WHEREAS, the sum of taxes plus foreclosure costs total \$3,900.96; and,

WHEREAS, R.C.W. 84.64.320 allows for Tax Title property to be disposed of without bids when the sale is to any governmental agency and for public purposes; and,

WHEREAS, Resolution 95-005 designated the Whatcom County Treasurer as negotiator in such sales; and,

WHEREAS, the Whatcom County Treasurer has negotiated a sales price of \$3,900.96;

NOW, THEREFORE, BE IT RESOLVED that it is in the best interest of the County to sell Parcel 400431-204542 having legal description of: BEAP 480 FT W-144 FT S OF QR COR BTWN SECS 30-31-TH E 150 FT-TH S 55 FT-TH W 150 FT-TH N 55 FT TO POB, to the City of Everson, Washington for the negotiated price of \$3,900.96, and further in this sale transferring all mineral rights; and,


BE IT FURTHER RESOLVED that said price shall not be allowed under contract and shall be paid in either cash, certified check, or money order to the Whatcom County Treasurer at the time of sale; and,




