3 DEVELOPMENT BLOCK GRANT

4 WHEREAS, Whatcom Self-Help Homes would like to work in partnership with the  
5 County to create an opportunity for the working families on their waiting list to build their  
6 own homes; and

7 WHEREAS, Whatcom Self-Help Homes is asking the County Council to request the  
8 administration to apply for a Community Development Block Grant of \$500,000 to help with  
9 the cost of land acquisition; and

10 WHEREAS, the grant does not require any county funding; and

11 WHEREAS, the grant will pay for any administrative expenses that the County might  
12 incur associated with the project; and

13 WHEREAS, the grant will not create a significant administrative or legislative  
14 burden; and

15 WHEREAS, the grant will have a clear start date of May 1996 and an ending date  
16 of December 1996; and


17 WHEREAS, the grant will not create a project or program the County would have  
18 to sustain nor will it create any on-going county responsibilities.


1           NOW, THEREFORE, BE IT RESOLVED that the Whatcom County Council


