WHEREAS, on February 28, 1995, the Whatcom County Council resolved to change the regular council meeting dates to every other Tuesdays,





TITLE 2
ADMINISTRATION AND PERSONNEL

Chapter 2.02 - COUNTY COUNCIL

2.02.010 Meetings - Times.

A. The regular meeting time of the council shall be ~~the first, second and fourth every other~~ Tuesday of each month at 7:00 p.m. in the Whatcom County Courthouse, unless decided otherwise by the council. Special meetings may be called by the chairperson of the council as required, provided proper public notice and notice to council members is given.

B. Regular committee of the whole items shall be discussed during the council meeting on the first ~~Tuesday meeting~~ of each month, unless decided otherwise by the council. This meeting may be canceled at the will of the council.
