AN ORDINANCE IN THE MATTER OF TRANSFERRING OWNERSHIP OF A NON-EXCLUSIVE FRANCHISE FROM THE KOK ROAD WATER ASSOCIATION TO THE CITY OF LYNDEN


WHEREAS, The Kok Road Water Association was granted non-exclusive franchises dated back to the 1950's; and


WHEREAS, The Kok Road Water Association has requested written consent from the Whatcom County Council to transfer all rights, obligations, title and interest over to the City of Lynden;

NOW, THEREFORE, BE IT ORDAINED by the Council of Whatcom County, Washington that this transfer has been approved and any and all franchises including all rights, obligations, title and interest granted to the Kok Road Water Association shall be transferred to the City of Lynden.

ADOPTED this 1 day of October, 1996.




