6 **AN AMENDMENT TO RESOLUTION NO. 95-080,**  
7 **REVISING SALARIES FOR UNREPRESENTED**  
8 **WHATCOM COUNTY EMPLOYEES**

10 **WHEREAS**, a Resolution in the Matter of Adopting a Salary Schedule for the Unrepresented  
11 Whatcom County Employees was adopted November 28, 1995; and,

12  
13 **WHEREAS**, changing circumstances call for modifications to the 1996 salary schedule; and,

14  
15 **WHEREAS**, those modifications have been assembled here for deliberation by the Whatcom  
16 County Council.

18 **NOW, THEREFORE, BE IT RESOLVED**, by the Whatcom County Council that the 1996  
19 Salary Matrix for Non-Represented Whatcom County Employees, is hereby amended by  
20 permanently adding \$80 to each monthly amount on the matrix, as shown in the attached Exhibit  
21 A, "Non-Represented Employees' Salary Matrix - effective July 1, 1996."

23 **AND FURTHER, THEREFORE, BE IT RESOLVED**, by the Whatcom County Council  
24 that the 1996 monthly salaries for Elected Officials and other unrepresented Whatcom County  
25 employees (which are not covered by the attached salary matrix) are hereby amended to provide  
26 for an increase of \$80 per month, per FTE to each, as follows:

45 that the salary changes contained herein are retroactively effective to July 1, 1996.




