16 funding assistance has been requested to aid in financing the cost of replacement of the Indoor
17 Range Backstop; and

19 **WHEREAS**, the County Council of Whatcom County considers it in the best public interest to
20 replace the indoor range backstop;

22 **NOW, THEREFORE, BE IT RESOLVED**, by the County Council of Whatcom County,

26 Interagency Committee for Outdoor Recreation for funding assistance;

28 2. That any fund assistance so received be used for the replacement of the indoor range
29 backstop at Plantation Range located in Whatcom County, Washington;

31 3. That Whatcom County anticipates its share of project funding will be derived from
32 the General Funds;

34 4. Whatcom County acknowledges that the County must support all non-cash
35 commitments to the local share should they not materialize;

37 5. That this resolution become part of a formal application to the Interagency
38 Committee for Outdoor Recreation.




