9 ORDERING AN ELECTION FOR THE  
10 PROPOSED POINT ROBERTS SPECIAL RECREATION SERVICE AREA

12 WHEREAS, on September 10, 2002, the Whatcom County Council  
13 received a petition from the Point Roberts Chamber of Commerce in  
14 support of the creation of a Pt. Roberts Special Recreation Service Area;  
15 and

17 WHEREAS, attached to the petition was a certificate of sufficiency  
18 signed by the Whatcom County Auditor certifying that the petition  
19 contained the signatures of at least ten percent of the registered voters  
20 within the proposed recreation service area boundaries; and

22 WHEREAS, in accordance with RCW 36.68, the Whatcom County  
23 Council has reviewed the reports and studies received from the Point  
24 Roberts Chamber of Commerce which determine the feasibility of forming  
25 the district and outline costs involved in obtaining the objectives set forth  
26 in the petition; and

28 WHEREAS, on February 11, 2003, the Whatcom County Council held  
29 a public hearing in accordance with RCW 36.68.450; and

31 WHEREAS, at the conclusion of the public hearing the Council voted  
32 to forward the petition to the Whatcom County Auditor by approving  
33 Resolution No. 2003-013.

35 NOW, THEREFORE, BE IT RESOLVED by the Whatcom County Council  
36 that the Whatcom County Auditor shall set an election for this proposed  
37 Point Roberts Special Recreation Service Area to be held at the next general  
38 election or at a special election held for such purpose, submitting to voters  
39 within the proposed district the following proposition:


