**AN AMENDMENT TO RESOLUTION NO. 2004-067**

**A RESOLUTION IN THE MATTER OF ADOPTING A SALARY SCHEDULE AND POLICIES FOR UNREPRESENTED WHATCOM COUNTY EMPLOYEES FOR THE YEAR 2005**

**WHEREAS**, a RESOLUTION in the Matter of Adopting a Salary Schedule and Policies for Unrepresented Whatcom County Employees for the Year 2005 was adopted November 23, 2004; and,

**WHEREAS**, further review of circumstances per sections 7.1.1 and 10 of the RESOLUTION has called for modification to the RESOLUTION and,

**NOW, THEREFORE, BE IT RESOLVED**, by the Whatcom County Council that sections 2.1.1, 3.2 and 7.1.1 of Resolution 2004-067 are hereby amended as follows, and this amendment shall become effective retroactive to January 1, 2005

**2.1.1 Exhibit A – Non-Represented Salary Matrix.**

For ranges 100 through 220, a new step "I" will be added which will be 1% higher than step "H".

For ranges 230 through 410, a new step "I" will be added which will be 3.8% higher than step "H".

**3.2 Other Positions not on a Salary Matrix.**

Court Reporter	\$4,569
Health Officer	\$8,767

**7.1.1 Wage Adjustments for Elected Officials.** Elected Officials, except Council Members, shall receive the same overall wage adjustment to their 2005 salary (per Resolution #2004-067) as granted non-represented employees for 2005. Council Members shall be compensated per Resolution 2001-067.

AND FURTHER, THEREFORE, BE IT RESOLVED, that Resolution No. 2004-067 is hereby amended as described herein effective retroactively to January 1, 2005,
