ORDINANCE NO. 2006-052
AN ORDINANCE AUTHORIZING THE LEVY OF TAXES
FOR COUNTY CONSERVATION FUTURES PURPOSES
IN WHATCOM COUNTY, WASHINGTON,
FOR THE YEAR OF 2007
PURSUANT TO HOME RULE CHARTER SECTION 6.10

WHEREAS, pursuant to Home Rule Charter Section 6.10 the County Executive is required to submit for Council consideration a budget and proposed tax and revenue ordinances necessary to raise sufficient revenues to balance the budget; and,


WHEREAS, the County Council has approved a budget, for the 2007-2008 biennium, including all sources of revenues and anticipated expenditures; and,

WHEREAS, the biennial budget provides detailed listings of various revenues including property taxes; and,

WHEREAS, the County Council has held a public hearing concerning the biennial budget, the property tax rates, and revenues included therein.

NOW, THEREFORE, BE IT ORDAINED AND ESTABLISHED by the Whatcom County Council that an increase in the regular Conservation Futures property tax levy, in addition to any amount resulting from the addition of new construction and improvements to property and any increase in the value of state-assessed property, is hereby authorized for the 2007 levy in the amount of \$ -0-, which is a percentage increase of 0% from the previous year.
