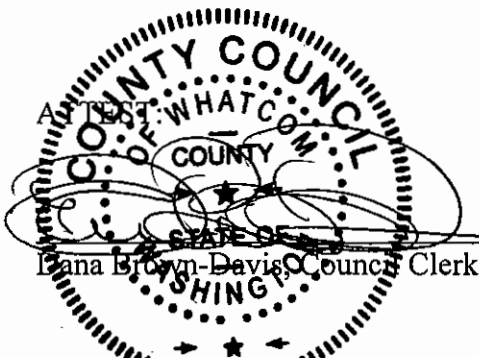
CANCELLING UNCOLLECTIBLE PERSONAL PROPERTY TAXES
