22 Improvements from Bennett Drive to Locust Avenue Vicinity.

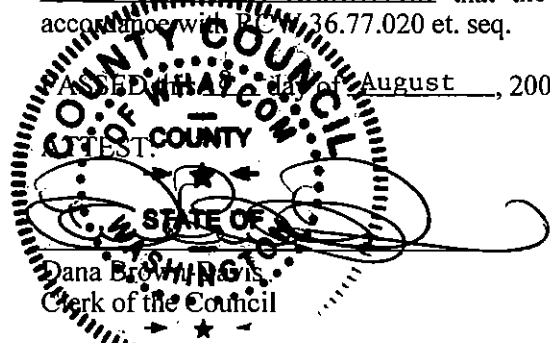
