14 Lynden Road/Blaine Road (SR 548) Intersection Improvements" is listed as project priority
15 No. 9 on both the STIP and ACP, and

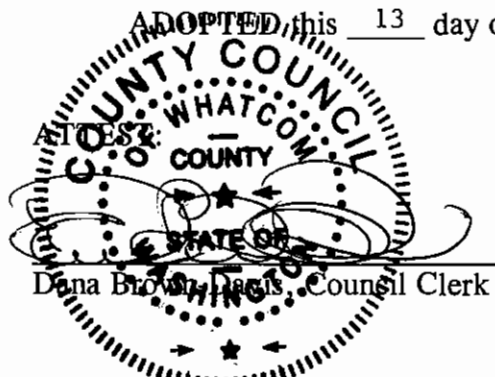
