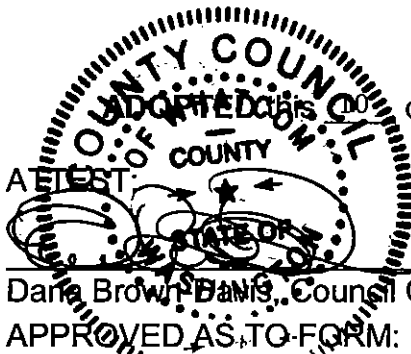
ORDINANCE NO. 2007-037
