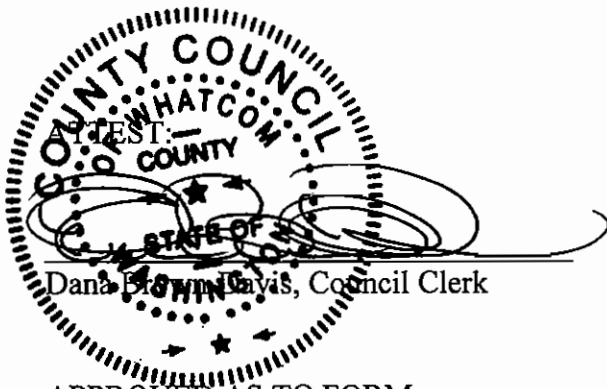
RESOLUTION NO. 2007-006
