18 Improvements, Various Intersections.

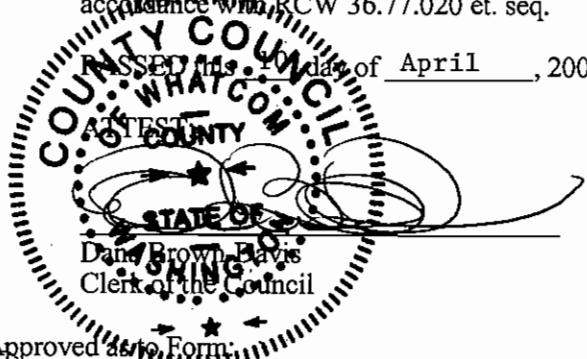




