9 **CERTIFYING AND ACCEPTING THE PROPOSED POLL BOOK**
10 **FOR THE NORTH LYNDEN WATERSHED IMPROVEMENT DISTRICT**
11 **FORMATION ELECTION (AN IRRIGATION DISTRICT)**

13 **WHEREAS**, on July 27, 2007 the Whatcom County Agriculture Preservation
14 Committee filed a petition with the Whatcom County Council to form an irrigation
15 district in the Bertrand Watershed area; and

16
17 **WHEREAS**, on September 11, 2007, Council voted to accept the petition,
18 setting in motion the formal process for organizing the district as outlined RCW
19 87.03; and

20
21 **WHEREAS**, an election will be conducted by mail ballot to decide if the
22 district shall be formed; and

23
24 **WHEREAS**, participants in the election are limited to owners of property
25 within the boundaries of the proposed district, with two votes given for every five
26 acres (or fraction thereof) of property owned; and

27
28 **WHEREAS**, the Whatcom County Agriculture Preservation Committee has
29 determined that the district will contain less than 200,000 acres, which determines
30 the qualifications of electors and the voting method under State law; and

31
32 **WHEREAS**, Council staff has prepared a poll book for consideration by
33 Council; and

34
35 **WHEREAS**, the poll book includes only parcels of property within the
36 proposed boundaries of the district that are less than three acres, excepting all land
37 within the City of Lynden and all tax-exempt parcels; and

38
39 **WHEREAS**, the poll book is required to determine eligible voters; and


40
41 **WHEREAS**, eligible voters must be 18 years of age, United States citizens,
42 Washington State residents, and owners of property for which they are casting
43 votes.

44
45 **NOW, THEREFORE, BE IT RESOLVED** by the Whatcom County Council that
46 the poll book presented to the Council and attached to this resolution, or on file in
47 Council file AB2007-322B, is hereby certified as being as accurate as possible.



We removed all items that were specifically not parcels of land, such as mineral rights. We also removed all parcels of land less than three (3) acres.
