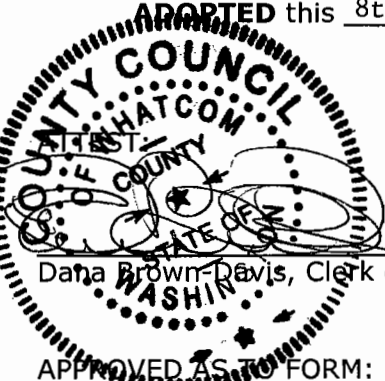
**ORDINANCE NO. 2008-024**

**ESTABLISHING A EAST WHATCOM REGIONAL RESOURCE CENTER CONSTRUCTION FUND**

**WHEREAS**, Whatcom County seeks to build a community facility in eastern Whatcom County for the provision of early childhood education, family support and health services (East Whatcom Regional Resource Center); and

**NOW, THEREFORE, BE IT ORDAINED** by the Whatcom County Council that a new fund is hereby established, effective July 8, 2008, titled the "East Whatcom Regional Resource Center Construction Fund". This fund shall be used to account for the costs and revenues for the construction of the East Whatcom Regional Resource Center.
