6 A RESOLUTION TO CONSIDER  
7 VACATION OF A PORTION OF WILLOW STREET

9 WHEREAS, on June 14, 2005; Stephen Glenn, 7451 Birch Bay Drive, Blaine, Washington 98230,  
10 and others, submitted a petition for the vacation of a portion of Willow Street lying within the  
11 unincorporated area of Whatcom County, accompanied by the penal sum of \$682.00, and,

12 WHEREAS, as described in RCW 36.87.010, when a county road or any part thereof is considered  
13 useless the Whatcom County Council may declare its intention to formally consider vacation, by  
14 resolution.

15 NOW, THEREFORE, BE IT RESOLVED that it is the intention of Whatcom County  
16 Council to consider vacation of the following described right of way: a portion of  
17 Willow Street in Government Lot 1, Section 36, Township 40 North, R1 West, W.M.,  
18 and Lot 3, Section 31, Township 40 North, R1 East, W.M. between Sunset Drive and  
19 Wooldridge Avenue, abutting lots 1 and 14 of Block 15 and lots 6 and 7 of block 14,  
20 Birch Bay Park.

21 Subject to and/or together with all easements, covenants, restrictions and/or  
22 agreements of record or otherwise. Also subject to Whatcom County retaining  
23 an easement the length of the area to be vacated for utilities and drainage.

26 AND BE IT FURTHER RESOLVED that the County Engineer investigate and report to the County  
27 Council on the matter of the proposed vacation of said portion of Willow Street so that the Council  
28 may set a public hearing on the matter.



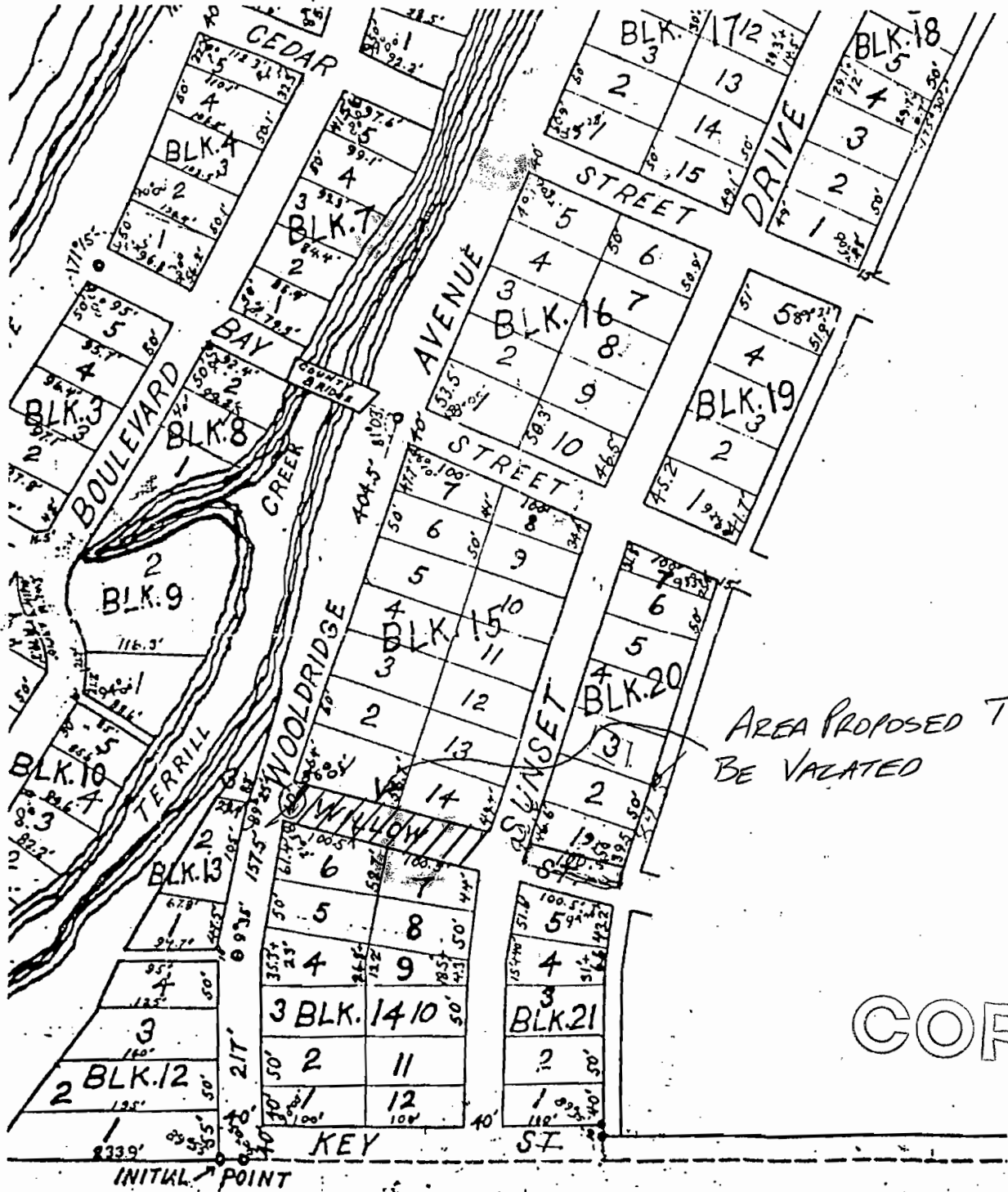
