WHEREAS, the mission of Whatcom County government is to protect and promote the health, safety and welfare of our citizens in an efficient, accessible, and effective manner; and

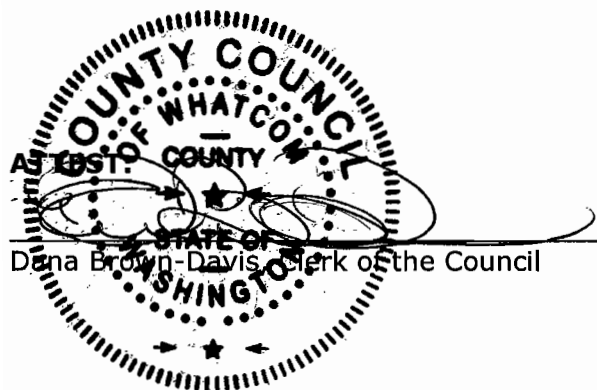

WHEREAS, the County Council Chambers is county property and also a suitable venue for public auctions; and


WHEREAS, the public benefits associated with this event are clearly consistent with, and in support of, the County's mission and goals.
