11 regular meeting schedule; and

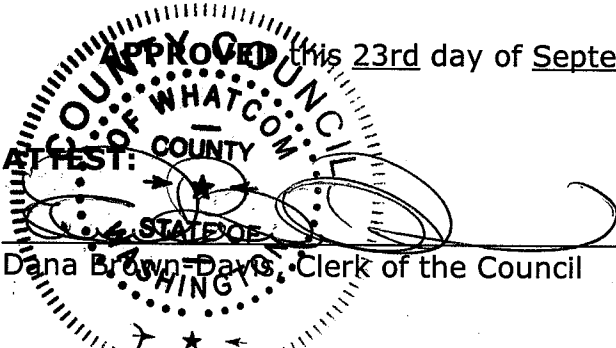
