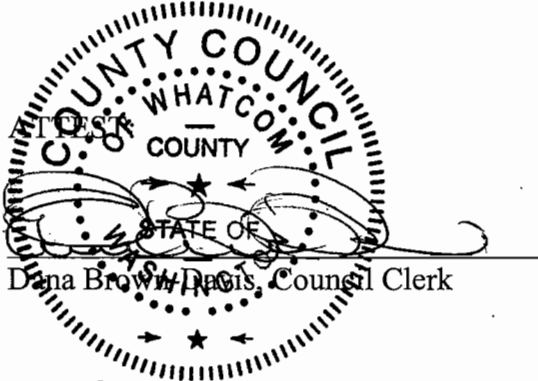
RESOLUTION NO. 2009-002


