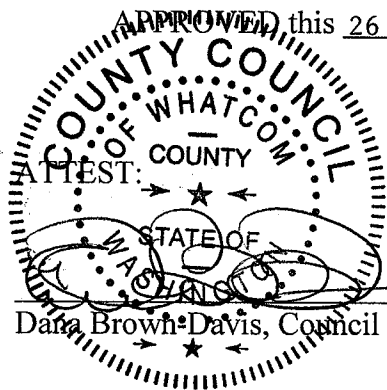
RESOLUTION NO. 2010-003

WHEREAS, Council action is required to formally cancel the uncollectible personal property tax;


