That CRP No. 908013 is formally amended to include the construction of the Baker Lake Road Sulphur Creek Bridge #422 Replacement.

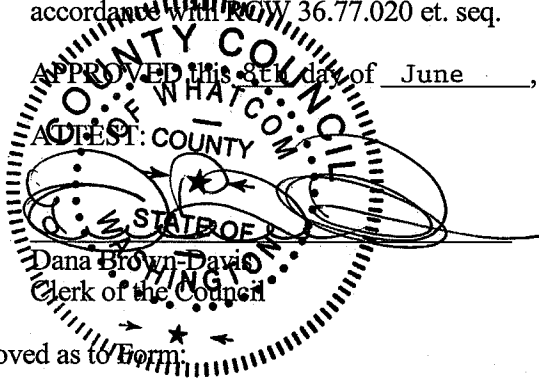
The Contract for this project is awarded to **Interwest Construction, Inc.**, in the amount of their bid of **\$1,168,168.00**
