My wife Kathy and I are especially interested and very concerned regarding proposed LAMIRD changes to our present GC (General Commercial) designated property zoning here in Point Roberts.

Presently, at our location at the intersection of Tye Drive and McKenzie Way (SEE ATTACHMNET ABOVE), we have businesses consisting of :

- a. warehousing,
- b. light assembly
- c. postal services
- d. electrical contracting services
- e. retail appliance sales

We have a total of 7 outlets, totaling 8000 sq/ft of "true" commercial shops combined in building #1 and #2.

There are 7 full time employees in building #1. Building #2 is new and will employ another 7 to 10 full time employees when fully operational.

We would be greatly impacted should there be any changes to the use of our GC (General Commercial) zoned property should there be added restrictions to the businesses that are presently allowed, therefore we are especially concerned of these new proposed LAMIRD zoning changes.

It would be much appreciated if you would keep us informed as to the proceedings and to any and all proposed land use "amendments" that may affect our present land usage.
